# VIII. Superintendents Presentation

Dr. Petty asked Roberto Mendez, Supervisor of Special Services, to address the Board on ensuring the delivery of special education and related services to students with disabilities. Mr. Mendez informed the board that he email to all parents of special education students and spoke to the information and guidance he gave to the parents.

Caroline Haskell-183 Corabelle Avenue- I was wondering how going virtual will work out for parents who have to work full time? I am not questioning going virtual, but what if parents aren't able to be home during the day to sit with their elementary children. They now have to find childcare let alone, find someone to monitor them online. Some parents aren't fortunate to be able to stay home or don't have an alternate plan for their kids. They now have to pay for childcare 5 days a week - 8 to 9 hours instead of just the after-school care until the parents get home. So a concern of mine is if a parent can't have a child online for the set amount of time or the set hours that they are required to be online what is to happen? Will they be marked absent or assignments marked incomplete? What if these children have IEP's and they need that face to face with their teachers. You are all addressed, not just the families who are able to be home to do virtual learning with their children. Please stay safe and God Bless.

Student will not be peanlized if there are issues with parents working and not being able to access virtual learning. Parents should communicate with staff with concerns.

Amalia Harvath-100 Kipp Avenue Unit 1- If you are starting off the new school year of 2020/2021 with remote and all virtual learning, will you accommodate parents who wish to continue that option for the entire length of the school year if in-person and/or hybrid options continues to deem unfit and unsafe. What is the criteria that will determine and require schools to physically re-open? My concern is the HVAC in all of our schools. Poor ventilation that can very well affect students with underlying health issues especially during a pandemic that will require majority of the students to wear face coverings. How will you ensure the health safety of our children when you have parents that send their own in sick, covering up their fever with medicine?

Mr. Luna addressed the HVAC ventilation and that it meet requirements for school opening. No sick children will be allowed in school and masks will be worn.

Jennie Jimenez-44 South Main Street- I understand that having the necessary PPE is top priority and it's completely understandable why we cannot open our schools safely. I do wonder why the lack of ventilation hasn't being discussed in the reopening plans? Lack of ventilation is a serious issue and not to mention, our schools don't have ACs. Air circulation and filtration options should be part of our discussions and I don't believe the CDC has provided much guidance on that. What are we doing on our end to rectify or somehow improve these issues?

# XVII. Hearing of Citizens (on all matters)

Daniel Moimenta-25 Hope Street- My son is entering Pre-K. What will his daily schedule look like? What equipment does he need for remote learning? Will Lodi be providing tablets/laptops for students?

All instruction will be virtual when school opens for the 2020-2021 school year. Teachers will be using google meets to hold instruction and the plan will be re-assessed as the school year progresses. Device will be made available to students if needed. Building principals should be contacted for devices.

Karen Viscana- 18 Garden Street- I have been hearing complaints concerning the lack of cleanliness at our Middle School. Has this problem been brought to anyone's attention? Do we have a sufficient amount of custodians?

Anthony Luna, Jr. stated that all schools have been cleaned and are ready for school opening. If anyone notices an issue with a school their concern should be bought up to the school principal.

Ryan Curioni-76 Liberty Street- 1) Without using semantics or answering a question that is not being asked, can someone please provide the public with the true figure of what Cleary Giacobbe billed during its first year with the district. This would be for the time period of July 1, 2019 thru June 30, 2020. From billing \$900 to review a basic OPRA request to paying multiple attorneys to participate in same zoom meeting, the public can see a clear pattern of waste and abuse from this politician run law firm. Lodi taxpayers have been taken adantage with these outrageous bills.

- 2) Nancy Cardone's sister in law, Lodi teacher union president Francine Santos, ran a union campaign to prevent any in person learning in the Lodi schools. During a special afternoon meeting this past Friday, Nancy Cardone voted for the teacher union's wishes. Nancy Cardone took \$4,000 from the NJEA during her last campaign and has countless relatives employed in the Lodi schools. I hope the public is aware of Nancy Cardone's conflicts of interest so it can see that Nancy Cardone always puts her family's special interests before that of Lodi students.
- 3) Trustee Sharon Salvacion also took \$4,000 from the NJEA and has a daughter that is employed in the Lodi schools (member of the LEA). Sharon voted to take away all in person learning options from Lodi students. I hope the public is aware of Sharon's conflicts of interest so it can see that she always puts special interest groups and her own special interests before that of Lodi students.

President Schrieks informed all the legal bill can be requested though an OPRA, and are public record. Also the contribution amount indicted in the comments is an aggregate amount and not per individual.

Sara Scimeca- 73 Avenue B- Since lack of PPE is the reason being given for students starting virtually, does that mean that there are no current HVAC or ventilation issues in any of the buildings? The CDC is saying MERV 14 filters are necessary - do all the buildings have these filters? If so, will we be receiving any documentation before our children go back into classrooms that show the HVAC systems are up to code and aligned with the CDC guidelines?

Mr. Luna responded to the HVAC ventilation and that it follows the guidelines for school reopening.

Karen Viscana-18 Garden Street- What accomadations have been developed for our special needs students? Will the district provide meaningful staff development to help remote and hybrid learning so we can provide cohesive learning experiences?

Mr. Mendez presented to the Board his plan for special services and the method of accommodations for the students the will require these.

Yujeini Gonzalez-Altamar- 49 Howard Street- Will laptop computer be loaned to students in Middle/high school?

Parents are to contact school principals for devices.

Francis Antoine-106 McKinley Avenue- Thank you for formally making the call for students to temporarily go all virtual for the time being, it's clear it is the safest choice at the moment. The lack of supplies and poor ventilation in the school buildings are most definitely big factors for health and safety of our children. With that in mind, why are you requiring teachers to report and teach from the buildings? If these safety measures are unsafe for the students, why would they be safe for hundreds of the teachers sharing the school building, supplies and equipment?

Elementary School teachers will not be room sharing. Middle School and High School will be limiting room sharing between the teachers and the classrooms will be cleaned during switches.

Cindy Barbato-119 Kennedy Drive- When will the BOE stop having Zoom meetings and go back to meeting in person? If the BOE doesn't think it's safe to meet in person 1 or 2 days a month, then why is it safe to send teachers into the schools for a full day 5 days a week?

The Board Office will not be able to hold a meeting open to the public and follow social distancing rules in the current space at the Lincoln School Administrative Building.

Chris Cannella-62 Liberty Street- Thank you for selecting the safest option for our students, staff and community and deciding to open the school year remotely!

Christine Tadros-87 Bel Vista Court- Some of us have multiple children who will have virtual classes taking place during the same time. Will you provide a laptop for the students who are in need?

Parents should contact building principals for devices.

Jorymel Jaquinet-119 McKinley Avenue- Will students be provided with laptops? If so, when wil l they be handed out?

Parents should contact building principals for devices.

Karen Viscana- 18 Garden Street- I'm confused...board members voted no on any raise for someone working in our district for years over 2.5% ...yet had no problem starting a teacher new to our district at step13?

Alicia Ciofalo-Hilltop School Teacher- The comment that the district is not increasing expenses to mandate teachers to teach remotely from the buildings is incorrect. The district approved this evening to increase the cost of internet services by over \$155,000. If teachers were permitted to teach remotely from home the district would not need to increase it's internet service.

The district will be increasing the internet bandwith to allow for Hybrid learning when school reopens. Will also allow for multiple teachers to stream from the schools.
